Hotel Performance - NI

January-June 2023

Northern Ireland Statistics and Research Agency (NISRA) accommodation statistics for January-June 2023 indicate hotel room occupancy experienced a minor increase while bed occupancy declined marginally compared with the same period pre-pandemic. Year-to-date room sales have decreased in January-June 2023 compared with 2019. Room occupancy for June 2023 fell by 1 percentage point and room sales declined by 8% compared to June 2019.

Room and Bed Occupancy

- Northern Ireland (NI) year-to-date (YTD) hotel room and bed occupancy figures sit at 65% and 51% respectively. These represent a 1 percentage point increase in room occupancy and a 1 percentage point decline in bed occupancy compared to 2019.
- Looking at individual monthly performance, room occupancy in June 2023 (81%) was down by 1 percentage point compared to June 2019. Room occupancy in June 2023 also increased by 6 percentage points compared to last month (May 2023 – 75% room occupancy).
- NI's 2023 YTD hotel room occupancy is 4 percentage points higher than last year (January-June 2022).

Room and Bed Sales

- Room sales in the month of June 2023 declined by 8% compared to June 2019. We had previously seen a monthly increase in room sales in April 2023 vs 2019, and a monthly decrease for May 2023 vs 2019.
- YTD room sales remain 5% below January-June 2019. This is one percentage point lower than the figure reported in last month's report.
- Bed sales in June 2023 decreased by 2%. This followed from a 4% decline in bed sales reported in May 2023.
- YTD bed sales for January-June 2023 are on par with 2019.
- Compared to last year (2022), January-June 2023 room and bed sales are 2% and 1% below 2022 levels respectively.

Hotel Performance - NI

January-June 2023

Performance during January-June 2023 varied across NI Local Government Districts (LGD). Belfast City recorded the highest room occupancy of all the NI LGDs (74%) and was the only reporting LGD to experience a growth in YTD room occupancy compared to 2019.

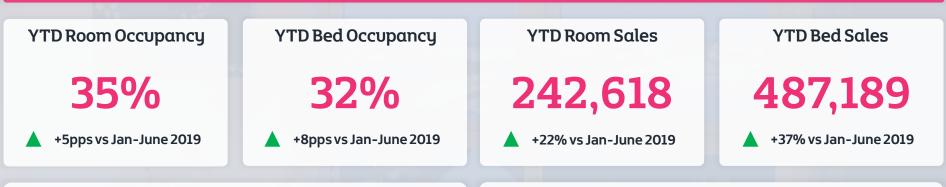

GH/GA/BB Performance - NI

January-June 2023

Northern Ireland Statistics and Research Agency (NISRA) accommodation statistics for January-June 2023 indicate that guesthouses, guest accommodation and B&Bs (GH/GA/BB) experienced increases in both room occupancy and sales compared to 2019 and 2022 figures. Performance suggests this sector is continuing to progress better in its recovery than hotels.

Room and Bed Occupancy

- Northern Ireland guest houses, guest accommodation and B&Bs (GH/GA/BB) have had a positive January-June 2023 period, with room occupancy experiencing growth of 5 percentage points compared to 2019. Bed occupancy has seen larger growth of 8 percentage points.
- Looking at individual monthly performance, room occupancy in the month of June 2022 experienced growth of 6 percentage points compared to the same month in 2019, marking the sixth consecutive month of growth vs 2019.
- GH/GA/BB room and bed occupancy have increased by 10 percentage points and 7 percentage points respectively in comparison to last month (May 2023).

Room and Bed Sales

- There have been over 242,000 rooms and more than 487,000 bed spaces sold in guest houses, guest accommodation and B&Bs in January-June 2023
- NI GH/GA/BB room sales for January-June 2023 have increased by 22% compared to January-June 2019.
 - Looking at individual monthly performance, room sales in June 2023 grew by 18% compared to June 2019. This follows on from increases of 10% in May, 18% in April, 26% in March, 13% in February 2019, and 73% in January 2019.
- Compared to last year (January-June 2022), GH/GA/BB room sales have increased by 3% in 2023.



GH/GA/BB Performance - NI

January-June 2023

Room and bed-space occupancy varied across Local Government Districts (LGDs) during January-June 2023. Belfast City LGD recorded the highest room occupancy (53%), while Lisburn & Castlereagh LGD recorded the largest increase in room occupancy compared with January-June 2019 (+14pps).
